1 What is Foreign Workers Insurance Guarantee?

Foreign Workers Insurance Guarantee serves as a security deposit to the Immigration Department to cover repatriation in the event your worker is required by the authorities to be send back to their country of origin during their stay in Malaysia.

- You must inform us the immigration office which you are applying for the work permit.

? Can I cancel my policy?

- No. if the insurance guarantee has already been lodged to the Immigration Department.
- Yes. If the policy is not lodged with the Immigration Department and the original insurance guarantee is returned to us for cancellation, the premium shall be refunded less the stamp duty.
