## 1 What is BizOne Loss of Profit?

BizOne Loss of Profit provides you with coverage for loss of profits, revenue, rental income, standing charges, wages or salaries on payroll basis, and/or increase in cost of working upon any business interruption by fire, lightning, explosion caused by gas used for domestic purposes or other extended perils stated in the policy.

## 2 Know Your Coverage

**As an illustration**, for **RM780.00** [annually], you will receive the following insurance **coverage** with Sum Insured **RM500,000** (on Gross Profit) if your property is occupied as Restaurant with Building Construction Classification C1A and extended with Explosion (non-domestic) and Riot, Strike and Malicious Damage:

### 3 Know Your Obligations

### 4 Other Key Terms

<ul style="list-style-type: none"> <li><b>Duty of Disclosure:</b> You must disclose all material facts which is known or ought to know, that would affect our underwriting consideration of your proposal, such as your insurance and loss history. You must disclose all relevant facts truthfully and completely in your insurance application form.</li> <li><b>Change of risk:</b> You must inform us of any material changes during the policy period. This ensures that necessary amendments can be made and endorsed to your insurance policy.</li> <li><b>Insurable interest:</b> You must have an insurable interest in the insured property, which means you would suffer a financial loss if it is lost or damaged.</li> <li><b>Sum Insured:</b> You may insure on an estimated sum insured in consideration of your Gross Profit/Gross Revenue/Gross Rental for previous year, as per your statement of account plus projected profit for the current year, if any. If the actual amount earned is less than the estimated sum insured, a pro-rata return premium not exceeding 50% of the provisional premium paid will be made in respect of the difference.</li> <li><b>Excess:</b> It is the amount of loss you have to bear before we indemnify you.</li> <li><b>Premium:</b> The premium due must be paid and received by Liberty General Insurance Berhad within 60 days from the inception date of the policy. Failing which policy is automatically cancelled and we are entitled to the pro rata premium on the period we have been on risk.</li> <li><b>Claim:</b> You must notify us immediately of any claim and take reasonable steps to minimize the loss or damage.</li> <li>This policy shall cease if your company be wound up or is carried on by Liquidator or Receiver or permanently discontinued.</li> <li>This policy must be issued concurrently with the BizOne Fire insurance policy.</li> </ul>
<b>Note:</b> This list is <b>non-exhaustive</b> . You should refer to the policy for the full list of terms and conditions.

### ? Can I cancel my policy?

- Yes. You may cancel your policy at any time by giving written notice to us. Upon cancellation, you are entitled to a partial refund of the premium.
- There may not be any refund of premium if only minimum premium is paid or a claim has been made on the policy.
