## 1 What is UOB Business Platinum Card Group Travel Personal Accident?

- pregnancy-related conditions
- acupuncture
- pre-existing medical conditions
- illnesses
- diseases
- bacterial/viral infections (except certain cases)
- travel contrary to medical advice

- injuries/illnesses after 30 days of the journey

You must disclose all relevant facts truthfully and completely in your insurance application form.</li><li>• <b>Change of risk:</b> You must inform us of any material changes during the policy period. This ensures that necessary amendments can be made and endorsed to your insurance policy.</li><li>• <b>Claim:</b> You must notify us of a claim within 14 days of the incident, or as soon as practicable if delay is unavoidable.</li><li>• <b>Benefits for expenses</b> (such as medical costs) are paid on a reimbursement basis, if you hold multiple policies, the total paid will not exceed the actual loss.</li><li>• <b>To be covered and receive benefits</b> under this Overseas Travel Personal Accident Policy, the Cardholder/Cardmember must charge the full fare of each trip or journey to the credit card(s) listed in the master policy. Coverage is subject to all other terms and conditions.</li></ul> <p><b>Note:</b> This list is <b>non-exhaustive</b>. You should refer to the policy for the full list of terms and conditions.</p>

### ? Can I cancel my policy?
