Non-Consumer Insurance Contract

Pursuant to Paragraph 4(1) of Schedule 9 of the Financial Services Act 2013, if you are applying for this Insurance for a purpose related to your trade, business or profession, you have a duty to disclose any matter that you know to be relevant to our decision in accepting the risks and determining the rates and terms to be applied and any matter a reasonable person in the circumstances could be expected to know to be relevant, otherwise it may result in the avoidance of your contract of insurance, refusal or reduction of your claim(s), change of terms or termination of your contract of insurance.

The above duty of disclosure shall continue until the time your contract of insurance is entered into, varied or renewed with us.

You also have a duty to tell us immediately if at any time after your contract of insurance has been entered into, varied or renewed with us any of the information given in this Proposal Form is inaccurate or has changed.

1. What is this product about?

Workmen's Compensation is an insurance plan that indemnifies the Insured against all sums for which the Insured shall be liable to pay as compensation to any employee for accidental personal injury or disease sustaining or arising out of or in the course of their employment.

2. What are the covers / benefits provided?

Cover provided by this policy is for employees who are workmen within the definition of Workmen's Compensation Act 1952 (Act 273).

The policy will compensate all employees who are "workmen" in respect of death or injuries due to accidents or occupational diseases arising out of and in the course of their employment.

Duration for cover is One year. You will need to renew the insurance plan annually.

3. How much premium do I have to pay?

The total premium that you have to pay may vary depending on the underwriting requirements and annual payroll/wageroll you declared to us.

5. What are some of the key terms and conditions that I should be aware of?

Some of the key terms and conditions that you should be aware of are:

- a) Every notice or communication must be given to us in writing.
- b) "Workman" is defined as any person who has, either before or after the commencement of this Act, entered into or works under a contract of service or of apprenticeship with the employer, whether by way of manual labor or otherwise, whether the contract is expressed or implied or is oral or in writing, whether the remuneration is calculated by time or by work done and whether by the day, week, month or any longer period

c) The Insured must take reasonable precautions to prevent accidents and disease and must comply with all statutory obligations.

- d) The name of every employee and their wages must be properly recorded. If the amount differs from the amount stated in the Policy, the premium will be adjusted accordingly at the end of insurance period.
- e) Cover can be extended if a workmen chooses to seek compensation at court. The Company's liability under the Common Law is subject to a maximum limit of RM1,000,000.00

- b) We are not liable to pay damages to any employee who is not a "workman" within the meaning of the Law
- c) We will not pay the Insured against loss damage injury due to war invasion act of foreign enemy hostilities.
- d) We are not liable in respect of any sum insured which the Insured would have been entitled to recover from any party but for an agreement between the Insured and such party.
- e) Decline Occupation Blasting Workers, Boiler Scales, Dam Construction Ship Builders, etc.
